- ➤ The candidate should be from Karnataka to get reservation.
- ➤ 80% admission seat reservation is for Karnataka candidates.
- ➤ Out of 80%, 20% seats are reserved for SC & 5% seats are reserved for ST.
- ➤ CBSE, ICSE & non Karnataka candidate should submit the eligibility certificate from DTE Bengaluru.
